PURPOSE

The Delaware Division of Substance Abuse and Mental Health developed the PIPBHC program to address the needs of individuals within our communities with mental illness and substance use disorders. Henrietta Johnson Medical Center, La Red Health Center are Federally Qualified Health Centers (FQHC) that support better health

care coordination that gives everyone a chance at a healthier and fuller life.



The PIPBHC Program will assess clients by Screening, Brief Intervention, and Referral to Treatment, with scientifically guided practices. A care manager will develop a care plan to be overseen by a health care provider and the client will be referred to community support services. Peer support is also available.

What is PIPBHC?

Full integration and collaboration in clinical practice between primary and behavioral health care for substance use disorder and mental health services.

Who do we serve?

Delaware citizens in need of substance use and mental health services.

What does it cost?

Each health center accepts most health insurance plans, including Medicaid and Medicare. A sliding fee scale is available for those without health insurance. Costs can vary according to each FQHC's billing practices.
